

The passing of the Assessment was a huge win for us all. The payments will help us to minimize the interest that we will have to pay as we use the line of credit to get all the work done. The deadline for payment is February 15th, 2024. Paying the assessment in full minimizes the increased cost for paying late or over a payment plan. I understand that this is a hardship for many of our residents. As I have repeated many times before, this is not a Want, but this is a huge NEED. Our reserve study will give us a much clearer picture of our future financial needs as well.

As I consider our lives together here in Hollybrook, I always consider, "Quality of Life". The service that our employees provide is the biggest factor in this equation. I have taken every opportunity to express to the employees how grateful we are for their continued work and dedication. It is so easy to lose focus when things are not kept in order, or a plan has not been established. ## December Operations Budget Analysis Reveals Fiscal Responsibility and Community Compliance



The December Operations Budget Analysis indicates we are at 75.94 percent of our annual budget allocation. As part of this report, I would

like to address certain issues I consider important relative to our community.

Social media has innumerable purposes, expressing views, opinions, wants, however, it also percolates less than accurate facts and positions. What social media isn't is a method to enact or develop plans to be put in place in communities like ours. Broadcasting on social media what you want doesn't present a viable procedure or even a plan for any administration to try to implement. If you have an idea and believe it would be beneficial to all of us, come in and tell us about it. Don't rely on us viewing or hearing about something through social media.

On Sunday, December 10, 2023, CBS television broadcast Facing South Florida with Iim DeFede. On that date, Mr. DeFede interviewed Florida State Senator Jennifer Bradley about proposed legislation dealing with Florida condominiums in the next legislative session. As I listened to her presentation, I was pretty much relieved as many of the subjects she touched on were topics and procedures that Hollybrook has been following for many years. Specifically, our election process, candidate status, mailing requirements, scheduling and ballot integrity, counting processes, are all currently in place and compliant with Florida Statute 718.

Once the election is over, all directors and officers are required to complete a certification training program. This is, again, something we have required and have followed for a number of years. In point of fact this past election, our training program was done in house, with our attorney explaining the nuances of our documents, the state statutes, and our responsibilities and obligations as directors and officers. Options to do this course of study online or in person are always available. We chose the in-person method as it enabled us to have questions and answers discussed and explained.

Hollybrook uses the services of two banking organizations: Banco Popular and Bank of America. We have various types of accounts in each of these institutions. Specifically, Banco Popular has provided substantial loans for us, including our current line of credit loan, and maintains a number of our accounts as solid collateral for our loans. Depending on the type of accessibility required for the account, the interest rates on the funds vary. A Money Market account is earning 3.8 percent interest.

Hollybrook has utilized the services of a reserve study company for approximately nine years. This is a system initiated by our Controller, Alex Ivanskas, and we have continued forward to the present. A reserve study evaluates our assets and computes the costs for replacement and repairs. This year a new set of requirements were mandated by our State Legislature, requiring fully funding of a number of categories: roofs, painting-waterproofing, electrical, plumbing, structure (concrete), and fireproofing. Basically, we have two reserve studies in play, one with respect to the mandated fully funding and one with respect to all other assets. These reports are currently being analyzed and evaluated by our officers, controller general manager, and accounting professionals. As the computations and analysis are presented, the finalized information will be presented to our community.

Lastly, Hollybrook has an active website which contains all our documents, Declaration of Condominium, Articles of Incorporation, ByLaws, Rules and Regulations, copies of our Annual Audits, agendas and minutes of our Board of Administration meetings. These and other items are accessible on our website to all unit owners. Our new Director of Communications has indicated she will be scrutinizing the site and will continue to ensure that all information is compliant with statutory requirements.

Our team of officers, directors and Hollybrook staff are working to make sure we are acting in the best interests of each and every resident of our community. Our hope for the New Year is that all of us experience lots of love, happiness, good health, and success in the coming year.

## Financial Secy's Report: From the Desk of Joni Esser-Stuart

## A Time of Reflection



Writing my last report and final column for the Voice of Hollybrook (VOH) of 2023 has caused me to reflect upon the year. First, I want to say that it has been both an honor and a priv-

ilege to serve as your Financial Secretary and to assume other responsibilities throughout the year. I remain mindful of my duties and my obligations to our community. I have endeavored to serve with integrity and reverence to my commitments to our Unit Owners. It is not always easy to be an active participant of our Board of Administration (BOA) but others will no doubt verify that I "speak my truth" as we deliberate and discuss solutions to the problems that confront our community. I am grateful for many things including effective working relationships with Unit Owners, staff, and my colleagues on the Board. We don't always agree with one another but we have been able to agree to disagree on specific issues in an atmosphere of mutual respect.

All Unit Owners should have received a letter, via either snail mail or email, confirming the results of the Special Membership Meeting and the passage of a \$5,001,702 Special Assessment. The assessment will be due on February 15, 2024. The letter detailed payment options for Unit Owners. Copies of the letter are available in the main lobby of the Administration Building. Please contact me via email (financialsecretary@hollybrook. com) if you have any questions about the assessment or your payment options.

Our Lunch & Learn Lecture Series continues to be popular and well attended. Working with my liaison, we already have programs planned for January, February, March, and April. Please continue to read the Voice of Hollybrook (VOH), email blasts and monitor your bulletin boards for these free lectures. RSVPs are required for each event since lunch is provided as a part of this Enhancement Program. These catered luncheons also increase restaurant revenue. Again, thanks to our sponsors who pay for the luncheons and kudos to Michael Fishman and his staff for providing awesome dining for the attendees. I again want to take this opportunity to express my gratitude to our wonderful volunteers and our dedicated staff. Each event is supported by both staff and volunteers and none of these Lunch & Learn sessions would be successful without their help and assistance.

The November golf course income was \$146,281 which was greater than the revenue generated in October (\$114,691). However, by the end of November, we reached only 50 percent of our projected yearly golf income of \$1,880,000. Unfortunately, the first eight months of 2022-2023 had greater gross golf income (\$1,172,145) than the same period of 2023-2024 (\$943,662). I remain concerned that we will not be able to reach our projected yearly golf course income in the remaining four months of our fiscal year. Weather has played a role and negatively impacted our revenue but perhaps the 2023-24 projected yearly golf course income was not realistic or achievable. I would strongly advise that the 2024-25 Budget Committee and the Board carefully evaluate the data from the current year as they project income for the next fiscal year.

A further analysis of golf course gross income in November reveals that the cart fees from our owners were \$94,466 and an additional \$23,965 came from guest fees. As would be expected during the winter season, less of our income comes from outside golfers. Walk-in golfers accounted for \$2,224 of our golf revenue. Our contracts with Golf Now and Canam provided \$22,341. Golf Now revenue was \$6,355 and Canam revenue was \$15,986. Additional sources of golf income were \$617 from our military and first responders, driving range fees of \$1,602 and Par 3 fees were \$764. We also had an additional \$300 from other sources but there were no tournaments in November.

Alex Ivanaskas and Etna Chery are diligently working with me to collect from owners who are in arrears. We speak regularly with our unit owners who have financial difficulties and try to seek solutions prior to undertaking legal remedies to collect payments. As of December 14, 2023, sixteen owners are currently in Collections with Straley and Otto and at least one of these units went into Collections following the death of the Unit Owner. An additional seven owners were sent to Collections this week. Hollybrook is truly quite fortunate to have a very small number of accounts in collections, approximately one percent. In a condominium community of 1902, we can be extremely proud of both our low number of units sent to Collections as well as the small number of unit owners in arrears.

December is the time of year for Unit Owners to renew golf bag storage, pay for lockers and renew their TOTAL contracts. There is a representative from TOTAL in the main lobby of the Administration Building during the morning. Carmen Bruneau is especially busy during December since she handles the golf, liquor, and shoe locker payments in addition to bicycle registrations. Kudos and a special thank you to Carmen for her role as an active volunteer in our community. Finally, as we finish 2023, please remember to pay your Quarterly Maintenance Payment in early January.

## **REGULAR BOARD OF ADMINISTRATION MEETING MINUTES**



#### Wednesday, November 29, 2023

President Mike Eaton called the meeting to order at 7:35 pm on November 29, 2023. The Special Membership Meeting was conducted in the Playhouse.

The purpose of the meeting was to determine whether a quorum of proxy votes, 952-unit owners had been attained. The

quorum is a simple majority: (1,902/2) +1. If we attained a quorum, then we would determine if the Special Assessment was approved or rejected.

President Eaton asked Elaine Yost, the Recording Secretary if we had a quorum. She replied "yes"; we've received 980 affirmative and 35 dissenting votes for a total of 1,015. The assessment was approved by the community.

#### **NEW BUSINESS**

#### MOTION A - TO AMEND GOLF CHECK-IN PROCEDURE

Hand Koch made a motion to amend the Appendices, 3. Golf Booking Procedure (Chelsea System), A. Hollybrook ID Cards: All golfers must have in their possession their valid Hollybrook ID card each time they play golf. Each member with a tee time (when asked) must present their card when they pay for the round and again to the starter.

#### (Strikethroughs are deletions.)

Ginny Webber seconded the motion. Sylvie Gagnon (3-305) signed up and spoke on the motion. A vote was taken, and the motion passed unanimously with 23 affirmative votes.

#### MOTION B - TO WITHDRAW A PREVIOUSLY POSTPONED MOTION

Curtis Rice made a motion to withdraw a previously postponed motion that would cancel the contract with the Chelsea Reservation System and engage in a contract with GolfNow.

Joni Esser-Stuart seconded the motion. A vote was taken, and the motion passed unanimously with 23 votes to withdraw.

#### MOTION C - TO APPROVE OVERNIGHT PARKING OF VANS

Myra Markowski made a motion to amend Rule 3, Section 2, Paragraph D., to allow overnight parking for residents with vehicles classified as vans. The update should read as follows:

Residents with Association approved pick-ups are permitted to park overnight (10:00 PM-7:00 AM) in the designated pick-up parking areas as well as Guest parking spaces in their phases that are not in front of the buildings. Residents with Association approved vehicles, classified as vans, are permitted to park overnight (10:00 PM-7:00 AM) in the designated pick-up parking area only. At the present time the designated areas shall be the twenty-four (24) parking spaces on the northeast side of the playhouse, and behind the playhouse. Guest parking spaces that are not in front of the residential buildings may be used by all vehicles during the hours of 7:00 AM-10:00 PM.

The following should be added to the Rules and Regulations Definitions:

1. "Authorized Vehicle" means for the purpose of Overnight Parking on the Condominium Property, a two (2) axle, four (4) wheel motor vehicle that is classified as a car, sport utility vehicle, mini-van, van, or pick-up trucks by the manufacturer thereof and which conforms to the size, appearance, and signage criteria set in the Rules.

#### (Underlines are additions.)



## Special Assessment Payment Deadline Draws Near

There has been a lot of concern within the Hollybrook community about the Special Assessment that recently passed. For some, the fee may be unwelcome but financially feasible. For others, the special assessment fee poses a financial stress that seems overwhelming.

However, if the special assessment had not passed, our quarterly maintenance fee would have increased significantly. As you know, once it has increased, it will never come down. A special assessment seemed to be the best resolution.

Here, in south Florida, there have been several issues that have impacted Hollybrook as well as other condo community budgets. Mainly, the Surfside condo collapse on Miami Beach that killed several people on June 24, 2021. One of the reasons that there was a collapse was that the board did not take care of repairs that were desperately needed, and no one wanted to increase their maintenance payments. In the past few years, we have had hurricanes that did massive amounts of damage. This caused our insurance premiums to skyrocket to us and everyone in Florida. Then, the Florida legislature decided to require inspections of condos and require fully funding reserves for replacement of several different categories. For years, Hollybrook has waived fully funding reserves, although we have funded some reserves, we are in better shape than most condos.

On December 20, 2023, the Hollybrook Book Club kicked off the season with its first meeting where we welcomed (5) newbies to the group: Suzanne Hall, Ricki Shore, Elaine Siegel, Gail Dym, and Arlene Kaplan. Amy Schilder led our group of (16) in a good discussion of "Signal Fires" by Dani Shapiro. We noted how well written it is, with interesting characters and themes, but some found the plot somewhat contrived.

Some of the assessments to other condos have been as much as \$30,000.

Looking at all our options, one of the banks we deal with allowed us to get a home equity line of credit. We only start paying interest when we use it. There are several roofs that need replacement; when that is completed, our insurance premium should come down. There is only one more year of life left on several buildings' roofs.

I wanted to assure my fellow residents that you are not alone. Not everyone can afford the assessment, but we've done some research into alternatives to paying for it. And we are trying to work with residents that need assistance with a monthly payment plan option. Ultimately, the vote and the Special Assessment reflect how we as a community will move forward to ensure our buildings are safe and well maintained, receiving the necessary repairs and renovations to provide peace of mind in the years to come.

The special assessment fee is due February 15, 2024. If you haven't already made payment arrangements, time is of the essessence! There are several options to explore, and it's important that each resident chooses the option that is best suited for their individual needs and budget.



• Eating Healthy and managing your health. Maintain a balanced diet rich in fruits, vegetables, and whole grains. Proper nutrition can positively impact mood and




energy levels. Also make sure you're monitoring your health by attending medical appointments, taking prescribed medications, and staying in contact with your medical provider.

## **Important Facts About Last Wills**

It's a common misconception that wills are only for wealthy people. In a will, you can outline who you want to receive your possessions when you die, including your bank accounts, your real estate, and items of sentimental value. If you have children under 18 years of age, you need a valid will in which you name a guardian.

Wills do not expire. After taking the time to create a will, doing it again is probably the last thing you want to do. Fortunately, a last will does not expire. However, your estate documents should always reflect your most recent property and life changes. For example, if you marry, divorce, have children, or acquire or lose property, reviewing and updating your last will and testament is prudent. Consider revisiting your will and other estate planning documents with an attorney at least every decade.

If you die without a will, state law governs the disposition of your property through a body of law called intestate succession. Dying without a will is called dying intes-

tate. Intestate succession is a legal process under which a state's intestacy laws dispose of an intestate person's property. Intestacy laws vary depending on the state, but typically, close relatives receive a share of an intestate person's property. Your immediate family (i.e., spouse, children, parents, and siblings) will often inherit first. If you do not have immediate family members, more remote relatives, like grandparents, may inherit your property through intestate succession.

If you die without a last will, your spouse may not immediately inherit your property. Usually, if your property passes through intestate succession and you are married with children from another relationship, your spouse will not receive all your assets. They may only receive a portion of your assets. This leaves spouses in a tough position to sort things out with stepchildren with whom they may not have a good relationship.

A last will is an important part of your estate plan. It's a good start, but

it does not convey certain powers. You may want to consider supplementing it with other essential estate planning documents. For example, suppose you become unexpectedly impaired during your lifetime and can no longer handle your own affairs or communicate your wishes. You would benefit from a health care directive that expresses your desires for any medical treatment you receive. With a durable power of attorney in place, you can also ensure that an individual you trust handles decision-making regarding your financial, legal, and medical needs.

Even though everyone would benefit from having a will, most Americans have not yet put together any estate plan. I'm reminded of a quote from an early nineteen hundred journalist: "Death is not the end. There remains the litigation over the estate." Don't leave your family in conflict. Prepare and give them this last very important gift they will surely never forget.

## **Postcards From Elsewhere**

Exploring the Colors and Culture of Cartagena

In March 2023, I found myself embarking on a journey to the vibrant cities of Cartagena and Bogota in Colombia. I opted for a carefully planned 5-day trip, strategically designed to explore the highlights of both these cities with a knowledgeable English-speaking Tour Manager.

## Where I Stayed: Bocagrande – Where Luxury Meets Security

Nestled in the upscale and secure neighborhood of Bocagrande, our travel group experienced the epitome of Colombian hospitality. Known as one of the most expensive and exclusive areas in Cartagena, this neighborhood offered a safe haven for our explorations. We stayed in first-class hotels, which elevated the overall experience for me.

#### Highlight of the Trip: A Dream Realized

My visit to Cartagena had a singular goal: to capture the essence of Afro-Colombian culture, especially the women adorned in colorful dresses, balancing fruit baskets on their heads. This fascination had ignited years ago after seeing a photo in a travel magazine! On one of our tours, I spotted these captivating women and seized the moment and was blessed with not one but three women gracing my photo! What a magical memory.

On another tour, I ventured to a coastal village founded by fu-

gitive slaves in the early 17th century – These inhabitants, also known as "Costenos", are descendants of those seeking freedom, and they continue to honor their African ancestry by speaking a dialect known as "palenque", a Spanish-based Creole language. As I explored the village, I encountered a teenager learning the ropes

of manhood under the guidance of his grandfather, while young girls were inside, apprenticing with their grandmother to master the art of homemaking. This was a refreshing departure from the virtual world most young people inhabit. Reflecting on my own upbringing, I found poignant similarities to when my mother was imparting important life skills and the importance of creating a home.

Returning home, I shared the joy I experienced on this trip by submitting photos of this experience. Much to my surprise, an image was included in Gate1 Travel's South American travel booklet.

My trip to Cartagena was more than just a vacation; it was an immersion into a rich tapestry of culture, tradition, and humanity. As I explored mangroves by canoe, and danced with villagers, I marveled at the beauty of diversity and the shared threads that connect us all. Exploring new countries

## **Bald Eagles Graces Hollybrook**

When I first moved to Hollybrook, it was for the winter of 2018. I was initially a "snowbird," seeking warm weather and sunny skies. I was at the time recovering from a brain hemorrhage and exercising on daily morning walks using initially a walker and then a cane. At the time I was not a birdwatcher or a wildlife photographer.



One morning in February I was surprised to see our national bird, a pair of American bald eagles, perched on the highest pine cypress tree at the southeastern edge of

the driving range lake. Like clockwork I saw them nearly every morning at the same time and place, we both seemed to be creatures of habit.

I returned in 2019 to become a full time resident and the bald eagles became part of my morning ritual walks. I vividly remember seeing them in the tall pine cypress tree and felt a "woosh" and shadow to my left. It was a huge juvenile eagle that was one of three nestlings hatched that year.

When I returned from my annual month-long trip to England to see my two daughters, the eagles were gone, and their tall pine cypress tree had been struck by lightning and cut down. That was the last encounter, or so I thought.

In the meantime, I had become an avid birdwatcher wildlife and photographer and with my new camera and zoom lens could now better capture the amazing wildlife around us here at Hollybrook.

Much to my surprise a fellow wildlife photographer I knew from Boynton



Beach started posting photos of bald eagles in Pembroke Pines the end of November. As it happened this was the same mating pair of bald eagles who visited Hollybrook, and their nest was 11 miles due west on Pines boulevard. The first time I visited they were actively building their nest and two weeks later it was nearing completion as they gathered moss and smaller twigs for bedding.

This mating pair of bald eagles are the only ones in Broward County and have been returning to this nest nearly every year since at least 2010. Local eagle enthusiasts have named them "Pride" and "Jewel." When the undeveloped stretch of land was slated to become residential property, the City of Pembroke Pines and Commissioner Angelo Castillo pushed for the city owned land to be environmentally preserved. The vote to keep the land for the eagles was unanimously approved in April of 2022. Last year "Jewel" had three eaglets (they normally lay two eggs each mating season).

Bald eagles typically live twenty to thirty years and mate for life. They're large, so their nests are built for a lengthy stay and need to accommodate both the male and female as well as up to three eaglets. Most nests are 6 feet across and can be as deep as 22 feet. Once the eggs are laid, they typically take 35 days to hatch. The young stay in the nest for another 10 to 12 weeks. Once the eaglets fledge, they stay near the nest for 1 to 2 months.

The mating pair usually return to the same nest every year, start their mating ritual, and begin to rebuild their nest again. It's not known how long eagles can bare young. It is speculated based on a small sample that they typically mate and have young for their entire lifespan.

If you want to witness this amazing mating pair of eagles you should venture out before sunrise, as they're most active in the early morning. Near the very end of Pines boulevard, you can turn left on 208th and you should see a group of birdwatchers and photographers. The eaglets should hatch the middle of January and you should be able to witness them fledge from March through April.



## Hollybrook Golf and Tennis Club's PGA Course: A Journey Through Time, Nature and Championship Golf

Nestled in the heart of Pembroke Pines, Florida, Hollybrook from foxes and raccoons to ospreys and wood storks. Today, Golf and Tennis Club boasts a PGA golf course that weaves through a rich tapestry of history, nature, and community engagement. From its roots in farmland to becoming the crown jewel of Hollybrook, the Par 72 Championship Course has undergone transformations, welcomed wildlife, and played host to both local and charitable tournaments.

### A Heritage of Farms and Fairways:



As Hollybrook broke ground in an area once dominated by farms and ranch land, the straight rows of Australian pine trees remain a testament to the region's agricultural past. Most are gone now, but the ones that remain can be found between Phase 1 and

Phase 2. Originally envisioned as a hotel and golf resort, the residential community now known as Hollybrook Golf and Tennis Club emerged, flourishing around the pre-existing Par 72 Championship golf course originally designed by William Mitchell. The golf course had been open to the community since 1968, however, the original developers of Hollybrook took over the management of the golf course in 1972 when they broke ground on the development of the 285-acre community they envisioned. Since Hollybrook officially opened in 1974, the PGA golf course has been the crown jewel of the community. By December of 1975 both golf courses were exclusively reserved for the use of residents.

#### Wildlife Sanctuary on the Green:

Beyond its challenging fairways and manicured greens, the PGA course at Hollybrook serves as a haven for wildlife. Engaging in the Audubon Cooperative Sanctuary Program two decades ago, the efforts of Golf Superintendent, Jim Goins, transformed the course into a habitat teeming with diverse species,



coyote sightings add to the course's vibrant ecosystem. Goins also spearheaded a project to remove invasive plants species and replacing them with native plants.

#### Honoring Legacy and Solving Challenges:

Jim Goins also undertook the wooden bridge/boardwalk which many of you will recognize as the Joel S. Hyman Memorial Bridge. This was a solution to a low area problem at the 13th hole. By creating a marsh, that area no longer posed an issue as a muddy and inaccessible area to golfers. It eventually became a touching tribute to our former golf pro, Joel S. Hyman, who was with Hollybrook for 39 years.

#### **Redesigning for the Future:**

In 2014, the PGA course underwent a transformative redesign by golf course architect Thomas Ross, addressing key aspects like drainage, fairways, cart paths, greens and tee boxes. The decision to modernize was guided by a commitment to excellence, and the massive project, funded by a golf reserve, avoided placing a financial burden on Hollybrook residents. Manicured greens, watered fairways, and strategically placed hazards make it a premier U.S.G.A-approved championship layout in South Florida.



The revamped Par 72 Championship Course, spanning 6,516 yards, stands as a testament to Thomas Ross's expertise. Featuring five tee boxes catering to varying experience levels, the course offers both friendly games and challenging tournaments.

Beyond its fairways and bunkers, Hollybrook's PGA golf course is a living testament to the community's evolution, commitment to nature, and dedication to providing an exceptional golfing experience. As the seasons change, so does the allure of this championship course, inviting both residents and visitors to partake in the legacy of Hollybrook Golf and Tennis Club.

## Enhancing Your Golf Experience: Updates and Guidelines from Hollybrook's Dedicated Golf Committee

The Golf Committee, along with input from Sylvie Gagnon, have been hard at work to improve all aspects of our golf experience. We recently spent time with our Pro Shop Staff and our Chelsea System representative to fine tune parameters to align with our rules and regulations. The following are some items you should be aware of.

#### Chelsea System Software Upgrade

To maximize the benefits of the System we require a software upgrade. There is no cost for this. Once upgraded, you will simply need to go to the primary hollybrook.com website under the tennis and golf tab and sign in with your same golf ID and password. At that point you can re-establish a bookmark if you so desire. This upgrade is expected to occur on December 27. The Golf staff will be trained and on hand to assist those that need help.

With this upgrade you will also be able to download the Chelsea Mobile app for your portable devices. Chelsea Mobile (Chelsea Reservations 2.0) provides the primary items such as allowing you to create, modify and cancel bookings as well as enter lottery requests. It will also allow you to go to the main website as the app is designed as a quick method of handling the most common actions on the site.

This upgrade will be made for the Golf Community now; however we will also be discussing adding links for Tennis and Pickle Ball in the future.

#### Training

Adam Scrimenti is organizing training sessions for our Pro Shop Staff with our Chelsea Rep. We will be taking advantage of the unlimited training and support that comes with our Chelsea program.

#### Player ID

It is imperative that we strictly enforce the rules below pertaining to the presenting of our membership ID when both signing in and then clearing with the ranger.

Rule 4, GOLF, #3 Tee Times- players wishing to play on either course may do so only after they have identified themselves in accordance with procedures established by, or under the authority of the board. Appendices- 2.Golf Booking Procedure Chelsea System. A Hollybrook ID Cards: All golfers must have in their possession their valid Hollybrook ID card each time they play golf. Each member with a tee time must present their card when they pay for the round and again to the starter.

While it may seem unnecessary as we become familiar faces in the Pro Shop, please understand that this must occur across the board. This step ensures that our booking rules are being followed and a fair experience is had by all. Be easy on your Pro Sop Staff because we have made that expectation very clear to them. Hassling them will only slow things down.

#### **Guest Bookings**

After reviewing the Chelsea Lottery Ranking system, a change was made to bring it in line with our rules. Appendices #2, H,

#1- Tee Time Points Allocation: The system ranks new requests based on the team's composition. A (bookings comprised of members only), B (bookings comprised of members and guests) and C (booking for an individual) are now correctly ranked according to our rules. Anyone submitting with a guest will be ranked after teams without guests.

Currently, bookings for guests can be done in one of two ways: 1. You can enter the member and then simply enter guest in the system or

2. You can enter the member name and then add the actual name of the guest.

If you see a booking with the same member name in all spots that is because it was generated by the pro shop and indicates one member with three guests.

As a reminder when requests submitted for the lottery become a booking, each person listed on the booking receives a point. If a member is replaced by another member or guest, the original member will still keep the Lottery point assigned. This will not be removed.

The Pro Shop is being proactive by printing out requests immediately before the Lottery runs and then after to see what changes were made. Should there be any abnormalities that may fall within Rule 4, GOLF, #7 Rules Infractions Process appropriate measures will be taken.

## Tee Time Bookings and the Chelsea Lottery System

The Chelsea Lottery System goes into effect on November 1, 2023 and lasts until April 15, 2024.

### Here are some things to know:

- 10 days in advance the Chelsea lottery opens and individuals and couples can make a request for a tee time
- 5 days in advance the lottery will populate the tee sheet.

• 4 days in advance – Members can add guests bases on availability.

• 3 days in advance – Members can add multiple groups of guests bases on availability.

• 2 days in advance – Non-members and third-party booking agents may book tee times based on availability

Nine-hole tee times are available off of the back nine (7) days a week from 7:00am – 8:24am.

Nine-hole tee times are also available after 3:00pm.

Please note that a nine-hole round is exactly that, nine holes. Golfers are not permitted to pay for nine holes and play as many holes as they can. This will be strictly enforced.

## A Fresh Look at the Driving Range Transformation

In an exciting development for golf enthusiasts, Hollybrook has recently completed extensive renovations on its driving range! Located at the entrance of Phase 2, the range boasts a picturesque view of the lake.

The primary objective of this ambitious project is to enhance the golfing experience by introducing a natural grass hitting area alongside the existing artificial turf. The intention is to

entice more golfers to utilize the driving range, ultimately boosting revenue for the club. The expansion of the grass hitting area adds nearly 50 yards, providing ample space for both seasoned residents and visiting golf enthusiasts.

A crucial step in the renovation process involved the removal of aged, contaminated soil that had been in place for several years. In its place, a new sport field 70/30 mix soil was intro-



duced, creating the ideal foundation for the club's new turf of choice – the resilient and vibrant "BiMI-NI" Bermuda grass.

The driving force behind this transformation goes beyond catering solely to the current residents. The

aim is to attract external golfers in search of top-notch practice facilities. Hollybrook believes that the allure of a well-designed and meticulously maintained driving range will draw golfers from beyond the community with the goal of boosting the success of our golf program.

This project also serves as a unique experiment for Hollybrook to gather valuable insights into the new turf's characteristics, including its response to watering, fertility needs and chemical re-

sistance. This experiment positions Hollybrook to make informed decisions about potentially re-grassing the entire course with this new turf in the future.

The transformed driving range opened Friday, December 22, 2023. It will be opened on Friday's, Saturday's, and Sunday's throughout the season. Monday through Thursday, golfers will be restricted to the mats only. The Driving Range will

be closed every Tuesday, beginning Tuesday, December 26, 2023 until 12:00 pm for maintenance. The transformed driving rangemarks a significant step towards elevating the golfing experience for both residents and outside golfers.

### **COURT RESERVATIONS**

For your reservation, the administration wants you to enter your last name only.

### **TENNIS PRO**

And, good news, as of November 27, we now have a new tennis pro, Tom Mar, who will do clinics for 2, 4 or 6 players at 11 a.m., Mondays, Wednesdays and Thursdays. The prices are: 2 players, \$75 for both, one hour / 4 players, \$20 each for one hour, 6 players, \$20 each for an hour and a half.

To book a clinic, you form your own group of 2, 4 or 6 players, then you notify Marie at marie.doye@me.com; she will inform Tom and reserve a court for your clinic. You will have to pay Tom on the spot in cash.

#### STRINGING

Tom also offers the stringing service. Here's how it works:

You will drop off your racket at the GOLF PRO SHOP; you will fill out a form specifying the desired tension; if you don't know, Tom will give you the recommended average tension. For material, you have two choices: synthetic or guts: \$39; and you send a text message to Tom to inform him at this number: 786-553-3522.

You can pay directly to Tom on the days he holds a tennis clinic or by Interac.

Of course, Tom will let you know when your racket is ready.
